ONGOING PROJECT

Enhancing Trade and Regional Economic Integration between India and Bangladesh (IBTA II)

With support of the US Consulate, CUTS Calcutta Resource Centre (CUTS CRC) along with CUTS Centre for International Trade, Economics & Environment (CUTS CITEE) undertook the study to examine key issues which affect bilateral trade through land routes along the border between the state of West Bengal and Bangladesh and explore trade opportunities that can be realised by addressing such issues.

After completing the Phase I of this project and submitting the final report of the same, CRC undertook the Phase II of the study. The overall objective of the study was to frame policy recommendations for: a) signing and operationalising of the Motor Vehicles Agreement and drafting/signing of a SPS Agreement between India and Bangladesh, hence to benefit and ease the efforts of the traders; and b) replicating *Border Haats* along the India-Bangladesh border towards leveraging the economic and social benefits accruing out of it. The project commenced on September 30, 2013 and concluded on December 31, 2014.

Advocacy & Networking

Following the inter-ministerial meeting jointly organised by CRC and CITEE, in partnership with Federation of Indian Chambers of Commerce & Industry (FICCI) in New Delhi on March 18, 2015, a final report has been prepared and will be published by CUTS International shortly. Comments and suggestions from experts of regional and national repute like Sandip Kumar, Commissioner of Customs & EP were sought and have been incorporated in this report.

Sustainable Development Investment Portfolio (SDIP)

Department of Foreign Affairs and Trade (DFAT), Australian Government has developed 'Sustainable Development Investment Portfolio' targeting the South Asian economy to promote water, food and energy security by enhancing the cooperation on and access to the transboundary resource base and knowledge sharing. The implementation time for this project is 12 years in three phases of four years each.

CUTS International has been chosen as one of the portfolio partners for carrying forward a defined set of activities in this regard. On the given background and rationale, the overall goal for CUTS is 'enhancing the value of DFAT's SDIP by linking its interventions with key actors and stakeholders through local and regional networks through policy research and advocacy'. CRC jointly with CITEE team adopted the following objectives in the context of SDIP:

- To have a thorough understanding of issues related to SDIP and the stakeholders' perceptions
 on the same.
- To strengthen the networking capacity and engagement in more advocacies and dialogues.
- · To engage in policy research, media and CSO mapping.

Prithviraj Nath and Sucharita Bhattacharjee contributed towards finalisation of the questionnaire for the Perception Survey. SDIP second phase field visits started in West Bengal in June 2015. Nath, Bhattacharjee and Sumanta Biswas travelled to Murshidabad to meet several government officials, progressive farmers, private entrepreneurs, other stakeholders and conduct household surveys in remote locations. Bhattacharjee and Sayantan Sengupta are presently consolidating recently concluded projects/studies on RE models in South Asia by different organisations to enrich the literature review.

The objective is to tweak the focus of the study as well as revise the field survey plan accordingly by mid-July. Nath along with CITEE team worked towards revising SDIP plan for 2015-16 to incorporate the anticipated budget cut and contributed in preparing SDIP Cover Brief and other relevant documents.

Bureau of Indian Standards Programme
